

**LINCOLN CHARTER TOWNSHIP
PARKS COMMISSION
SPECIAL MEETING**

Saturday, August 5, 2006

The meeting was called to order at 8:25 a.m. by Chairman Gardner at the Community Center Pavilion, 5575 South Roosevelt Road, for the purpose of scheduling adult soccer and softball tournaments and extending use of the Rockey Weed soccer fields.

COMMISSIONERS PRESENT: Todd Gardner, Bill Tucker, Rich Knapp, Mike Lucker and Kim Risk. **ABSENT:** Rick Knight.

USASA Tournament: Gardner, Tucker and Risk met with Bruno and Debra Trapikas to further discuss tournament hosting needs. The group agreed that Parks will handle concessions and collect parking fees to cover operational expenses. The Trapikas' will be exploring community resources with the help of Cornerstone Alliance. They plan to recruit local volunteers to carry out many of the hosting duties.

Lucker, seconded by Gardner, made a **MOTION** to proceed in creating a draft contract for the Regional Finals of the United States Adult Soccer Association National Cups Competition at the Rockey Weed soccer fields June 15 -16, 2007, to present at the September 5, 2006, Parks Commission meeting. **MOTION CARRIED.** Contract negotiation committee to include Knapp, Risk, and Debbie Bly of LYSL. Gardner will forward research on draft agreements for other sports tournaments.

World Series Tournament: Discussed request from Doug Connor of Great Lakes Lightning Softball to host World Series qualifying games in September at the Youth Baseball/Softball fields. Hoskins will contact LYBSA to see if their group will do concessions and ask for a committee member.

Risk, seconded by Gardner, made a **MOTION** to proceed in creating a draft contract for the Softball World Series qualifying games at the Youth Baseball/Softball fields September 23-24, 2006, to present at the September 5, 2006, Parks Commission meeting. **MOTION CARRIED.** Committee to include Knapp and Risk.

Request for Use of Soccer Fields: Tucker received a request from an adult soccer group to use the Rockey Weed soccer fields on Wednesday evenings this fall. He did not hear back with more information on number of fields needed and specific dates. Risk contacted LYSL and reported their schedule would not be set until the end of the month. **ACTION TABLED.**

Announcement: A Parks Commission Special Meeting will be held in conjunction with the Lincoln Township Board of Trustees meeting on August 15, 2006, at 7:00 p.m. in the Municipal Building. A Special Meeting notice will be posted for a quorum to be present.
